<b>Charitable purpose</b>	<p>OUR PURPOSE AND MISSION IS A SIMPLE ONE. HERE IN AMERICA WE ARE FAR AWAY FROM PEOPLE WHO ARE LIVING IN UNDERDEVELOPED THIRD WORLD CONDITIONS. WE DO NOT THINK ABOUT CHILDREN. YES, THE CHILDREN LIVING AT HOME, YET STRUGGLING TO MAKE ENDS MEET, HAVING TO CHOOSE BETWEEN GOING TO SCHOOL OR HAVING FOOD IN THEIR STOMACH BY WORKING. WE DON'T THINK OF THESE THINGS UNTIL WE SEE THEM ON TV AND EVEN THEN SOME OF US WONDER, "IF I DO GIVE, WILL MY GIVING REALLY GO TO SUPPORT THESE CHILDREN IN NEED OR WILL IT BE USED FOR SOMEONE'S PERSONAL GAIN AND OR LIFE STYLE." HAVING WITNESSED THESE CONDITIONS WITH OUR OWN EYES AND HEARING WITH OUR OWN EARS DURING ONE OF SEVERAL MISSION TRIPS TO THE PHILIPPINES, WE KNEW WE MUST TAKE ACTION TO HELP PREVENT THIS FROM CONTINUING. DURING ONE MISSION TRIP OUR CHURCH, AURORA FIRST SDA, HELPED HUNDREDS OF PEOPLE BY PROVIDING FREE MEDICAL CARE, PROVIDED MORE THAN 100 PEOPLE WITH RICE, CLOTHING, AND PROVIDING HUNDREDS OF CHILDREN WITH MEALS AND MANY OTHER THINGS. WE HAVE CONTINUED TO EXTEND THIS HELP TO THE NEEDY YOUNG CHILDREN BY HELPING THEM HAVE A BASIC ELEMENTARY EDUCATION. TO DO THIS WE RAISE MONEY, APPROXIMATELY \$50.00, FOR EACH CHILD'S SCHOOL REGISTRATION. IN ADDITION, WE SEND BOXES MONTHLY FILLED WITH SCHOOL SUPPLIES, CLOTHING, SHOES, SOMETIMES CANNED FOODS AND RELATED SUPPORT ITEMS FOR THESE HURTING AND HOMELESS KIDS. UNLIKE OTHER CHARITIES, 100% OF THE DONATED MONIES FROM CONTRIBUTORS GOES TOWARDS A CHILD'S EDUCATION AND SUPPORT OF THEIR LEARNING NEEDS. ALL OTHER ADMINISTRATIVE FEES ARE PAID FOR OUT OF OUR OWN SEPARATE SALARIES (NOT RELATED TO HELPING CHILDREN). THE MONIES AND ITEMS TO BE DONATED ARE TO BE FULLY ACCOUNTED FOR AND TAX EXEMPTION RECEIPTS NEEDS TO BE GIVEN TO THOSE WHO WILL BE SO WILLING TO GIVE. ALL WORK IS VOLUNTARY AND NO ASSETS ARE PLANNED TO BE ACQUIRED. IN ADDITION, WE HAVE WORKED WITH LOCAL BUSINESSES HERE TO HELP PROVIDE FOR THE GROWING HOMELESS.</p>
